The undersigned is directed to say that a proposal for establishment of a new B.Ed.College at Siliguri, Darjeeling with effect from the academic session 1989-90, with a view to cope up with the acute admission problem in the area, has been received by the Government. The North Bengal University has granted temporary affiliation to the proposed establishment of the College. The Organising Committee with Sub-Divisional Officer, Siliguri as President has decided to run the Institution at present in the morning shift of Narasingha Vidyapith, Siliguri, till the building proposed to be constructed with local fund is completed. The Organising Committee will reportedly start the institution with some voluntary retired personnel.

In the circumstances, the Governor, after careful emmination of the proposal approves the opening of a B.Ed.College as a special case, with effect from the current academic session under the North Bengal University subject to the following conditions:

The Organising Committee should construct buildings out of its own fund and provide furniture, equipment and books etc. for the College.

ii) there should be adequate arrangement for water supply and toilets, uringle etc.

urinals etc.

iii) the Governing Body will be constituted as per terms and conditions of the affiliating University in due Course.

iv) there should always be a reserve fund of at least 8.1.50 lakhs.

v) recruitment of staff for the course should be made through the usual procedure of selection through C.S.C. and voluntary staff should be replaced by new appeintees.

vi) on the sponsors' obtaining affiliation of North Bengal University in specific subjects, staff proposal, both for teaching and non-teaching may be submitted to this Department on the basis of actual requirement.

vii) the sponsors should find a separate suitable accommodation for setting up the College and starting the Course at present till new College building is constructed.

A detailed estimate regarding both capital cost, if any, and recurring cost for starting the College for acquisition of land, construction of building etc. should be prepared and submitted to this Department for getting it vetted by the concerned Planning Committee of Darjeeling and State Planning Board for administrative approval of the project as also for release of requisite fund from the allocations existing in the appropriate budget head of this Department.

This order issues with the concurrence of the Finance Department wide their U.O.No. Group B 1634 dated 29.5.90.
